In addition, one or more service-disabled veterans must control the management and daily business operations.

### **Disabled Owned Business Enterprise (DOBE)**

A disability-owned business enterprise (DOBE) is a for-profit business that is at least 51% owned, managed and controlled by a person with a disability regardless of whether that business owner employs person(s) with a disability.
